If more than 25 application are received, there will be a Written Test (objective type) for shortlisting the candidates for panel interview.**
2. Candidates are required to bring his/ her full bio-data in prescribed format duly affixed recent passport size photograph along with photocopies of testimonials / experience etc. However, original documents will also be checked at the time of interview. No TA/DA will be paid for attending the Interview, if any.
3. In case of tie in written examination, all the candidates who have same marks will be considered to have qualified for further rounds.
4. All eligible candidates are requested to be present 1 hour before the scheduled time on date of interview for necessary formalities.
5. Number of positions may vary according to requirement.
6. Young Professional-I will be engaged purely temporarily on contractual basis. Initial engagement of YP will be for one year which is extendable for two more years (01year at a time) subject to requirement of the services of the YP in the and satisfactory performance of the candidate after evaluation by officers of level of directors.
